What is going on... Current landowners (through a private commercial developer) want to turn their residential properties located at 4N262 & 4N316 Route 31, in St. Charles into a "social event venue" accommodating up to 240 guests and where alcohol can be served. The plan is to also build a 100+ parking lot on the properties that are immediately next to Route 31 --- Just South of the High School and near Wild Rose Elementary.



Why should you care? To list just a few reasons... of many:

- 1) The adjacent properties are entirely residential to the North, South and West and to the East, you will find public parks;
- 2) Traffic will become unbearable on Route 31, and MAJOR road renovations must take place on Route 31 in order to even try to address serious safety issues;
